

Privacy Policy for the conference "Strobl24"

The Österreichische Akademie der Wissenschaften (OeAW – Austrian Academy of Sciences) and the Universität Wien (UNIVIE – University of Vienna) take data protection very seriously and treat your personal data confidentially and in accordance with the legal regulations.

For Participants:

This part of the privacy policy is intended to inform you as a participant in the conference "Strobl24" in accordance with Art 13 in conjunction with Art 26 para 2 GDPR about the purpose(s), legal basis and about your rights regarding the processing of personal data by the joint controllers - the OeAW and the UNIVIE.

Purpose, scope and legal basis of data processing:

1. For the organization and implementation of the event, we process the following personal data that you yourself disclose as part of your registration for the event:

- a. Contact data (title, first and last name, telephone number, e-mail address (official and/or private), billing address, organization)
- b. Position
- c. Department
- d. Payment data
- e. Abstract content
- f. Travel information
- g. Accommodation information
- h. Dietary requirements
- i. General communication content data

The processing of this data is for the purpose of administering your registration (Art 6 para 1 lit b GDPR).

The processing of this mandatory information is necessary for the organization of the event. If you do not provide us with the data, participation in the event is unfortunately not possible.

2. Public relations and the documentation of the event: Photographs or recordings are taken at the event and are subsequently processed for public relations and documentation of the event.

The joint controllers are legally appointed to "*serve scientific research*" (cf. esp. §§ 1, 3 Federal Law on the Organization of Universities and their Studies/Universitätsgesetz 2002 - UG) or to "*promote science in every way*" (cf. § 2 Federal law on the Austrian Academy of Sciences/ ÖAW-Gesetz – ÖAWG).

In order to meet these requirements, the two institutions have to organize events and inform the public about their activities in fulfilment of their public duties. Thus, the legal basis for the public relations work and the documentation of the event, in particular by taking photographs, is in each case Art 6 para 1 lit f GDPR or Art 6 para 1 lit e GDPR in conjunction with §§ 1, 3 cipher 11 UG (for the UNIVIE) or Art 6 para 1 lit f GDPR or Art 6 para 1 lit e GDPR in conjunction with § 2 ÖAWG (for the OeAW).

Recipients:

Apart from the strictly purpose-related exchange of your personal data for the purposes of the joint organization and implementation of the event between the joint controllers, there will be no disclosure to third parties.

Any recordings/ photographs in which your person is recognizable may be published on media channels (e.g. website of OeAW and UNIVIE, in social media) as part of the documentation of the event.

Storage period:

In the course of contract fulfilment or to comply with legal obligations: We will store your personal data for as long as it is necessary to administer your event registration, at the longest until one year after the end of the conference. In addition, we store your data if legal retention periods exist for this purpose or if limitation periods regarding potential legal claims are open.

In case of legitimate and public interest: We process the data for as long as legitimate or public interests exist or until a (justified) objection is raised.

Your rights:

In connection with the processing of your personal data, you have the following rights at any time, which can be asserted against both institutions (OeAW and UNIVIE):

- Right of access (Art 15 GDPR),
- Right to rectification (Art 16 GDPR) or erasure (Art 17 GDPR) or to restriction of processing (Art 18 GDPR),
- Right to data portability (Art 20 GDPR),
- Right to object (Art 21 GDPR),
